  - Sending their objection in writing, together with a statement of the grounds thereof, to the auditor, Audit Scotland, 4<sup>th</sup> Floor, South Suite, The Athenaeum Building, 8 Nelson Mandela Place, Glasgow, G2 1BT. Objections in relation to the accounts of the Health & Social Care Partnership should be marked for the attention of Peter Lindsay CPFA (Senior Audit Manager) at the address stated, **and**;
  - Sending their objection in writing, together with a statement of the grounds thereof, to the Controller of Audit, Audit Scotland, 4<sup>th</sup> Floor 102 West Port, Edinburgh, EH3 9DN **and**;
  - Sending a copy of that objection and statement to the partnership and to any officer of the partnership who may be concerned, both at West Dunbartonshire Health & Social Care Partnership, Council Offices, Garshake Road, Dumbarton, G82 3PU.
- The Auditor shall, if requested by the person objecting, the partnership, or by an officer of the partnership who may be concerned, afford to that person or partnership or officer, as the case may be, an opportunity of appearing before and being heard by the auditor with respect to that objection; and any such person or officer may so appear and be heard either personally or by a representative.
