- Continue to improve access to naloxone in the community and on release from custodial and hospital settings
- Establish protocols between mental health and alcohol and drug services to support access and outcomes for people who experience mental health and alcohol and drug problems
- Services are delivered in line with the Quality Principles: Standard Expectations of Care and Support in Drug and Alcohol Services, including clear plans to respond to the individualised recommendations within the Care Inspectorate Reports, which examined the local implementation of these Principles (<a href="https://www.gov.scot/publications/quality-principles-standard-expectations-care-support-drug-alcohol-services/">https://www.gov.scot/publications/quality-principles-standard-expectations-care-support-drug-alcohol-services/</a>)
- Ensure mechanisms are in place for people with lived and living experience of addiction/recovery and of participating in services to be involved in delivering, planning and developing services

- Implementation of DAISy before the end of 2020 in line with national DAISy implementation plans
