Age	The service will require to support young people age 16-26, as per national policy and legislation that direct the authority's duties to care experienced people. This allows a bespoke service that it tailored to the needs of young people who have care experience, who are likely to have experienced trauma and adversity in their childhoods. It also allows safeguarding and age appropriate support, specialist to supporting and maximising independence. The Children (Care, Care Experience and Services Planning) (Scotland) Bill proposes extending the aftercare support currently available for 16-to-26 year olds who were in care on their 16 th birthday to those who had left care before that point – including providing help with accommodation, education, employment and wellbeing, and therefore the service may require to be responsive to changing eligiblity/ resourcing as legislation and policy evolves.	The Children and Young People (Scotland) Act 2014 Children (Scotland) Act 1995 UN convention on the rights of the child The Promise, Scottish Gov, 2020	Positive - there are a lack of options for young people requiring supported tenancies at present. Having a range of options would allow the authority to meet statutory duties by allowing young people choice, being able to monitor outcomes and manage quality of provision.

Disability	It is likely that young people referred to the service will have a wide range of unique and individual needs. The assessment of suitability for the service will be undertaken by their allocated worker from within the HSCP and agreed by the resource group. The provider is expected to have the resource, skills and experience to be responsive to individual need and accommodate for changing needs. This will include ensuring that a tenancy and the support package offered with this, is suitable to the young person's needs. It may include supporting young people to access additional supports, particularly those related to independent living, managing income, engagement with supporting services, and all other aspects of wellbeing. The provider is expected to have experience of working with young people with varying needs, including diagnosed or undiagnosed disabilities or additional support needs. Care experienced people often encounter barriers to accessing services and supports, therefore this aspect of the service will be crucial to supporting	WhoCares? Gender Reassign

As above, the provider will be expected to understand and respond to the needs of binary young people, Care individual young people, and to provide support that promote wellbeing. It is known that people who consider or transition gender are likely to have additional support needs, vulnerabilities and experience differing forms of oppression. Therefore the provider must be able to support the young person to manage and overcome barriers, access information about their rights, and ultimately to promote their independence in their community through building links with appropriate services and learning life skills, as well as building social connections.

There are new policies and legislation regarding transgender people and this impacts access to public services. It has been highly publicised and the trans people have experienced high level discrimination and attempts to socially exclude them. The impact of this cannot be minimised for vouna people's wellbeing and the Provider supporting a number of young people must be aware of best practice in supporting each young person's human rights, as well as responding to their individual needs.

Positive - person centered service founded on individual assessment of needs. However evidence shows that this remains a current issue, and therefore individual outcomes are important to review and monitor.

Marriage & Civil Partnership	People with care experience are likely to have experienced disrupted relationships in childhood, for many people this may impact on their abilities and opportunities to identify, form and maintain positive relationships in adolescence and young adulthood. The provider must have an understanding of young people's experiences and how this may impact their current presentation and relationships, in order to offer support that meets the individual where they are. Pregnancy & Maternity	The service may require to support pregnant people and young parents, who have care experience. They may also support the young person's wider family, to a certain degree, such as by including them in the care planning process when a young person requests this. The service will require to work in partnership with young people and with other services around them, to refer, support engagement and understanding, and to promote overall wellbeing outcomes. A personalised assessment for each young person will allow focus on prioritising the young person and the child's best interest. There may be times when there are competing interests or demands and the Provider must be able to manage this collaboratively with the allocated worker from the social work team. Pregnancy or parenting should not exclude a young person from accessing the service, but may require additional or adjusted support planning. Race

Children from black, asian or other minority ethnic groups are more likely to have care experience than white Scottish children. They can experience unique Human Rights: challenges in care, such as having carers from different backgrounds or ethnicities who aren't able to/ immediately understand their care needs, cultural needs or preferences. There are reported complexities and barriers for The experience of care for children and young people to maintain their identity and are Black, Asian or part of associated impact on mental health and wellbeing.

Unaccompanied asylum seeking young people may also become care experienced, or require access to this service. These young people will also each have unique needs, have experienced significant adversity and may require additional supports to settle in West Dunbartonshire and understand their new area, environment and the systems around them.

Therefore it is pertinent that the Provider have experience and expertise in supporting people from a wide range of backgrounds, skills in supporting people who speak other languages, have varying care and support needs.

Sex	Statistics show that male children are still more likely to be brought into care, and to remain in long term care, than female children. They are also more likely to experience disruptions in their care placements and to live in residential children's houses or group living settings. Significantly more unaccompanied asylum seeking children who arrive in the UK are male - almost 9/10 according to some reports relevant to England and Wales. Due to the National Transfer Scheme, this is likely to be similar in Scotland. Therefore the service may receive more referrals for males than females. However the priority of a person centered assessment remains and the service must respond to the relevant housing support needs of each young person as they are. Human Rights	Around 1% of the UK's population are Care Experienced,32 with nearly 15,000 children in care across Scotland today.33 However, evidence shows that Care Experienced people have vastly different life outcomes compared to non-Care Experienced people. Health

According to national data collected by the Independent Root and Branch Review of Care, Care Experienced people in Scotland are almost twice as likely to have poor health outcomes compared to people with no care experience. Studies have found worrying trends that include: care experienced children had more frequent contact with services related to mental, sexual and reproductive health. Care experienced children also had a higher rate of prescriptions for depression, psychiatric outpatient clinic attendances and acute inpatient admissions due to mental and behavioural disorders.

The proportion of care experienced children hospitalised due to injuries, drug poisoning and other external causes was also high compared to children in the general population. Although rare, mortality among care experienced children and young people was five times higher compared to children in the general population.

This can also vary depending on their experiences in care. Young people are more likely to experience mental health problems too, and barriers to accessing support, being heard and understood by services.

The provider must undertake an assessment of each young person's need and although the service is housing support focused, this will include supporting young people to manage their wellbeing, to access and remain engaged with services and to understand and make positive choices.
