These issues contribute to higher rates of Black children being placed into care, often without adequate consideration of kinship networks or cultural identity needs (Sebba et al., 2020). A critical factor exacerbating these disparities is the underrepresentation of Black social workers in Scotland. The social work workforce remains overwhelmingly white, young, and inexperienced in engaging with racially diverse communities (Scottish Government, 2023b). This deficit limits the sector's ability to provide culturally appropriate interventions, erodes trust between Black families and social services, and perpetuates racial inequalities in safeguarding decisions (Agbaje et al, 2024).
